Mary Porter, Wife of John ² Dunham, Identified by Gratia Dunham Mahony

John ² Dunham, oldest son of Deacon John ¹ Dunham and his first wife Susan/Susanna Kaino, had a wife named Mary. Until publication of the recent article in the 2025 summer edition of *The Register*, Vol. 179, No. 3, Mary's maiden name was unknown. Now her name has been discovered and proven by authors Joyelle Robinson and Robert Battle in an article "The Identities and Ancestry of Four Early Seventeenth-Century New England Women: Joan (Wife of Thomas ¹ Chillingworth of Sandwich and Marshfield, Mass., and Thomas ¹ Doggett of Concord, Weymouth and Marshfield, Mass.), Susan (Wife of Nathan ¹ Fiske of Watertown, Mass), Mary (Wife of John ² Dunham of Plymouth, Mass.), and Rose (Wife of John ² Waterbury and Joseph ¹ Garnsey of Stamford, Conn.)"

Mary Porter, wife of John ² Dunham

John ² Dunham, son of John and Susanna (Kaino) Dunham, baptized in Henlow, Bedfordshire, England on 19 February 1614/15 [TAG, 71:132], died 6th April 1692 in his 77th year [PChR 1:275; cf. PVR 135]. From the article by Mrs. John E. Barkley in *The American Genealogist*, cited above, "His wife is named Mary, who died his widow 20th March 1698 [PVR 136]. His will was made 2nd February 1691/2, and proved 16th April 1692 [*Mayflower Descendant 31:160-1*]."

Now, from the excellent article by Robinson and Battle [The Register Vol. 179, No. 3, pub. Summer 2025, p. 236-257], we have learned the full identity of the wife of John ² Dunham. The article begins: "In April 1638, Roger ¹ Porter, a 55 year old husbandman from Long Sutton, Hampshire, together with his daughters Joan, Susan, Mary and Rose, were listed among the passengers on the *Confidence* of London, due to sail from Southampton to New Egland."

From p. 240-257 the article gives pertinent dates about the English origin of Roger Porter and his first wife Alice Mulford who died in England probably before 1 February 1626/7. Alice was married to Roger Porter in Heckfield, Hampshire, England on 21 June 1608. Roger Porter was baptized in Long Sutton, Hampshire, England 31 March, 1583, the "son of Robert Porter and Anne". Heckfield and Long Sutton are about eight miles apart in Hampshire, England.

From p. 247 the parents of Roger Porter are shown to be Robert Porter, b. say 1541 and died by 10 June 1601 and his wife Anne Chapman who he married in Long Sutton 19 Sept. 1566.

From p. 248 Roger ¹ Porter was baptized in Long Sutton, Hampshire on 31 March 1583, and died in Watertown, Massachusetts 3 April 1654. His second wife Grace (Ravens) (Sherman) (Rogers) survived him. Roger Porter came to Massachusetts on the ship *Confidence* in 1638

with four daughters, Joan, Susan, Mary, and Rose. He was made freeman in Massachusetts in 1639.

The article goes on to prove that Mary Porter, daughter of Roger ¹ Porter and his first wife Alice Mulford was the wife of John ² Dunham.

Residence of John ² Dunham

Known as John Dunham, Jr. he was listed in Records of Plymouth Colony Vol. 1, p. 36-37, March 1651, with the names of those "that have interest and proprieties in the Townes land at Punckateesett over against Road Island". Page 53 notes "the bounds of John Dunham, Junior: his grant of forty acres of land on the southwest on Colchester is bounded . . .", and pages 57 & 99 refer to land of John Dunham Junior at Winnatuxett. [Ply. Co. LR from Mayflower Desc. Vol. 36 #1, p. 38].

John Dunham married Mary Porter probably in Watertown, Mass. about 1640. John and Mary settled first on a lot northeastward of his father in Plymouth, but sold out to Henry Wood early in 1643 [PCR 12:91]. They appear to have lived for a time at Wellingsley [PCR 12:110; PCR 12:114], before finally settling on a lot of land north of Plymouth village, "lyeing aboue the hieway goeing to Joanses Riuer" [PCR 12:179]. This was north of "Plain Dealing," later called "Seaside" [PTR 1:57]. He was a proprietor of Major's Purchase in Middleborough in 1674, but seems never to have lived there [PCR 5:150].

John's portion of his father's estate was received 28 May 1663, viz. "the one half of all that his share lot and portion of meddow att Winnatuxett . . . as also his whole portion of upland at the place forenamed" [MD 18:37-8, citing PCLR 2:2:119].

Will of John ² Dunham

The will of John Dunham of Plimouth was dated 2 Feb. 1691/2, and proved 16 April 1692 (Plym. Prob. 1:135-6), as abstracted in MD 31:160-161:

To "wife Mary Dunham and to my Daughter Mercy Dunham my house I now dwell in with all" personal property except as specified, "Also...all my land about two miles off from my now Dwelling house and the orchard there it all Containing About" 16 acres, "Also...one acre of meadow lying at Doties meadows" in Plymouth, also 40 acres "at Colchester in the Township of Plimouth aforesaid I give to my said wife and daughter Mercy to be equally divided betwixt them But...if my wife need her share of the land for her Support she may sell it...which land I value at" £10; but, if she does not sell it, "after her decease my son John Dunham" to have one half of it, "hoping he will be tender and Carefull to help his mother while she lives" [John Jr. died before his mother].

To "my son John Dunham my Best Cloth Coat, hereby Signifying he hath already Received his full portion"

To "my Son Bartholomew Hamlin and my daughter Susanna his wife I Give all the Rest of my wearing Cloaths both linnen and woollen from head to foote"

To "my son James Hamlin one shilling and to my daughter Mary his wife one shilling:"

To "my son Robert Barrow one shilling and to my daughter Lidia his wife and to the heirs of her Body for Ever thirty acres of land which I have lying at Monponset in...Plimouth."

"my wife & Daughter Mercy to be Executrixes" and "my loving friends Isaac Cushman and Ephraim Morton junr to be overseers" of the will.

The witnesses were John Cotton and Samuel Sturtevant.

"Mr Jno Cotton one of the witnesses" made oath to the will at Plymouth, 16 April 1692, before "William Bradford Esqr Dept Governr and Mr Ephraim Morton Associate."

TAG Vol. 30:148 states "she was still unmarried when her mother died (20 Mar. 1698/9), as shown by a deed to her on 17 Feb. 1698/9 (Ply. Co. LR 3:88), in which her mother gave to Mercy her half share of about 50 acres in Colchester in Plymouth township, which land had been left to her and daughter Mercy by the last will of my late husband with full power to sell if need be for her maintenance." (Ply. County Land Record 2:62 shows that Mercy had sold a half share left to her by her father on 5 June 1696).

She is probably the Marsey Dunham who married in Plymouth November 1701 Joseph ⁴ King who was born in Plymouth 16 Feb. 1680, (Sarah ³ (Dunham) King, Samuel ²

Dunham, John ¹ Dunham). (Plymouth VR p. 89) They had one child, Nathaniel born 26 May 1707 who died 7 February 1734/5. (Plymouth VR p. 40)

Daniel 5 Dunham, United Empire Loyalist, Revisited

Daniel ⁵ Dunham (Daniel ⁴ David ³ Jonathan ² Singletary/alias Dunham, Richard ¹ Singletary) has been researched and discussed before. He has been identified as the ancestor of several past members of this Dunham Genealogy Research Association but there has been no definite proof of his line back. DNA tests of his descendants show him to belong to the Singletary Dunham line, and descendants trace him to the United Empire Loyalists who came to New Brunswick, Canada following the American Revolution in 1783.

I worked on this line along with several others over 25 years ago. Very detailed research was done by Gloria-Jean Phillips of New Brunswick, Canada, Lloyd Dunham of Ontario, Canada (a past member of our Board of Directors), and several other descendants of this line. Just recently I received a query from Deborah Dunham, whose ancestor was David Elson Dunham (1839-1883), a well-known architect of Saint John, New Brunswick, Canada. Her interest at this time was a detailed letter written by her father, Roy Joseph Dunham, originally from Toronto

but then of the state of Michigan, and a World War II pilot serving in the US Army. Roy Joseph Dunham had flown over the deck of the battleship *Missouri* during the historical signing of the peace treaty by Emperor Hirohito of Japan on September 2, 1945, and then went on to drop supplies for POWs. Deborah thought that a reproduction of that account in this newsletter near the 80th Anniversary of that signing might be of interest to our readers. Working with Deborah again to follow this line back is what prompted me to revisit the research on this family.

I should say that during these past twenty-five years I have collected a great deal of material on the entire line of the descendants of Jonathan ² Singletary who assumed the surname of Dunham when he settled in Woodbridge, New Jersey in about 1665. Numerous articles have been written and published in this newsletter about them. It has been thought by many of the descendants of Daniel ⁵ Dunham, that he must have been the son of Daniel ⁴ Dunham of Elizabeth, New Jersey. No documentation of proof has ever been found but we do know that Daniel Dunham died in 1739, a constable in Elizabeth, New Jersey. No record exists of his marriage, or any children born to him. However, the Daniel ⁵ Dunham who went to Saint John, (then still in Nova Scotia) in 1783 along with other United Empire Loyalists from Woodbridge, New Jersey was very likely the son of Daniel ⁴ Dunham of Woodbridge, and a grandson of David ³ Dunham of Woodbridge.

Deborah Dunham Descendant of Roy Wolsey Dunham

When I received the query from Deborah Dunham, who wished to acknowledge the military service and the eye witness account given by her father, of the signing of the surrender by Japanese Emperor Hirohito to General Douglas MacArthur on the battleship *Missouri* on 2 September 1945, I wanted to revisit this line of descent from Jonathan ² Dunham of Woodbridge, New Jersey. There is no existing proof of this particular family but several clues provide strong circumstantial evidence that Daniel ⁴ Dunham was the man referred to as "constable" in Elizabethtown, New Jersey. We do not know his wife's name or when she was born or died, but the association with the Episcopal Church in Elizabethtown, New Jersey where the sixth-generation children were baptized, provides evidence that this family still lived there. Many residents of Elizabethtown were strong supporters of the King of England, and so it is not surprising to see that all but one of the sons in the sixth generation of this family were United Empire Loyalists and went to Canada after the Revolution was over.

As DNA test results have shown this family descends from the Singletary-Dunham line of Woodbridge, New Jersey. The lineage follows: (for more information on these first five generations please see the web site of Dunham Genealogy Research Association at www.dunham-singletary.org under Jonathan ² Dunham alias Singletary of Woodbridge, NJ)

Richard ¹ Singletary (1599-1687) and first wife prob a Dunham

Daniel ⁵ Dunham (say 1730-1821) and Catherine Campbell

United Empire Loyalists in New Jersey Including Second Cousin Asher Dunham

The largest number of the United Empire Loyalists were found in the middle colonies. Many had been tenant farmers of New York or New Jersey and many were farmers who held small farms or they were the sons of families who were of age to serve in the military. Some were Quakers who did not believe in war service, and some were recently arrived immigrants.

These groups of people who did not support the revolutionary cause, and were either neutral or opposed to the patriot cause for various reasons, rarely attempted any political organization. They were often passive, unless regular British army units were in the area on recruiting missions. The British assumed that a highly activist Loyalist community was ready to mobilize and planned much of their strategy around raising Loyalist regiments in the colonies.

Following the end of the Revolutionary War in 1783 many of these Loyalists could choose evacuation to Nova Scotia (which included New Brunswick at this time) where they were eligible to accept the British government's offer of free land. With the arrival of the fleets in 1783 carrying the Loyalist refugees to Parrtown (later renamed Saint John, New Brunswick) there was a need to politically organize the territory. The larger colony of Nova Scotia therefore was split and the colony of New Brunswick was officially created on 16 August 1784 with Sir Thomas Carleton as its first governor.

The Loyalists arrived in several fleets of ships sailing at different times. There were around a dozen different ships in each fleet but not all the names of the passengers have been documented. Also making searching for passengers more difficult is that the passengers on the May fleet and those on the September fleet were listed, but those on the June fleet were not identified, or at least the names no longer exist if they were. We know from many of the petitions for land in Parrtown, and from people who were later in Saint John that they must have come on the June fleet, but there is no proof. That seems to be the case with four of the five adult sons of Daniel and Catherine (Campbell) Dunham. These sons were:

Seth ⁶ Dunham b. say 1751, so age about 32 in 1783

Lewis ⁶ Dunham b. say 1754, so age about 29 in 1783

John ⁶ Dunham b. say 1759, so age about 24 in 1783

David Alston ⁶ Dunham b. say 1762, so age about 21 in 1783

Jonathan ⁶ **Dunham** b. say 1768, so age about 15 in 1783 (we know he was in Saint John but are not certain just when he came)

The names of the vessels composing the May fleet have often appeared in print, and their arrival at St. John is annually commemorated; the coming of the 'fall fleet' also is frequently and familiarly referred to; but the arrival of the June fleet appears to have been generally overlooked. The June fleet left Sandy Hook on June 16th and headed for its destination of Parrtown with a contingent of about 1,500 Loyalists.

While we do not have a list of the passengers, we do know the names of the vessels that made the June trip, as well as the names of their captains. The fleet consisted of thirteen ships and two brigs with a frigate as convoy. Among the vessels were the *Bridgewater*, (Capt. Adnet), *Two Sisters*, (Capt. Brown), *Hopewell*, *Symmetry*, *Generous Friends*, *Thames*, *Amity's Production*, *Tartar*, *Duchess of Gordon*, *Littledale*, *William and Mary*, and *Free Briton*. The Loyalists on board were enrolled in seventeen companies, commanded respectively by Joseph Clarke, Sylvanus Whitney, Joseph Gorham, Henry Thomas, John Forrester, Thomas Elms, John Cock, James Hoyt, Christopher Benson, Joseph Forrester, Thomas Welch, Oliver Bourdet, *Asher Dunham*, Abra. Camp, Peter Berton, Richard Hill and Moses Pitcher.

Asher ⁵ Dunham (1744-1803), son of Jonathan ⁴, Benjamin ³, Jonathan ² Dunham/alias Singletary, Richard ¹ Singletary Second Cousin to Daniel ⁵ Dunham

There has been much confusion over Asher Dunham and the question as to whether there was one man named Asher Dunham or two. We know that Asher Dunham served as a loyalist during the Revolutionary War, but there is also an Asher Dunham who served in the Middlesex Militia. These records of service were however, for the same Asher Dunham. We know that Asher Dunham served in the Middlesex Militia because his name appears on the Official Register of Officers and Men in the Revolutionary War. Following the war, Asher applied for back pay owed to him for his war service. From the State of New Jersey, Asher received a Certificate entitling him to receive two pounds sterling, thirteen shillings, and four pence for his

efforts. However, at the end of the War, most of the Colonies were bankrupt and these Certificates were often worthless.

Asher Dunham (son of Jonathan and Mary (Smith) Dunham) was 'born about 1745. He was a farmer and also was the part owner of a sawmill. When the Revolution broke out Woodbridge was considered to be a hotbed of patriotism. However, both Elizabeth and Perth Amboy had large complements of British Troops, and any pro-Independence action brought swift retaliation by the Redcoats. When American independence was declared in July of 1776, many residents of the Colonies, perhaps as many as two-thirds, remained neutral or retained their allegiance to the Crown. In November of 1776 Asher joined the British Army at their local headquarters in New Brunswick, NJ. Soon after his enlistment Asher was sent with a small party of men to Bonhamtown for the purpose of building defensive structures called redoubts. Within a month, he was commissioned a Captain and was issued a warrant to raise a Company of recruits under his command for the New Jersey Volunteers (Loyalists). Besides recruiting, he also collected intelligence for the British.

In 1838, local historian William Whitehead visited the Trinity Churchyard in Woodbridge, New Jersey and recorded the inscriptions on many headstones; however, he limited himself to only the inscriptions of those people who had died prior to 1800. Thus, Asher's stone was not recorded. The next recording of headstone inscriptions was not done until 1948 when a headstone for Asher Dunham was listed. It appears that Asher Dunham returned at some point from Saint John to New Jersey, and he died in Perth Amboy, New Jersey in 1803 at the age of about 59 years. He is buried in the Episcopal Church yard in Woodbridge. His will has been found in the U.K. National Archives:

England and Wales, Prerogative Court of Canterbury Wills, 1384-1858; Probate II: will Registers 1802-1804; Piece 1415; Heseltine, Quire numbers 654-704 (1804):

Last Will and Testament of Asher Dunham, probated 1 Oct. 1804. Just why the will was probated and recorded in the UK is unclear, but it does state "Asher Dunham of Perth Amboy", and gives his wife's name as Susannah Pike.

Continuation of the Line of Daniel ⁵ Dunham, son of Daniel ⁴, David ³, Jonathan ² Dunham/alias Singletary, Richard ¹ Singletary

Daniel ⁵ **Dunham** (Daniel ⁴ David ³ Dunham, Jonathan ² Singletary/alias Dunham, Richard ¹ Singletary) born in Woodbridge, Middlesex County New Jersey, or in Elizabethtown, (now Union County) New Jersey in 1730, ^[1] died in St. John, New Brunswick, Canada before 1821. ^[2] He married **Catherine Campbell**, ^[3] daughter of Joseph and Martha (--) Campbell. She was born 17 December 1734. ^[4] [Ref. 1-4 from Myers, Patty Barthell; Ancestors and Descendants of Lewis Ross Freeman, pub 1995 p. 566].

Daniel was a Tory (United Empire Loyalist) and went to Canada on the ship *Neptune* in the spring fleet in 1783. He received lot number 687 in Parrtown, later Saint John, New Brunswick. From the book "Early Loyalist St. John" by D. G. Bell, he lists the families as on arrival; Daniel, "*Neptune*", 1 adult male, 1 adult female, 3 children over 10 yrs. 2 children under 10 yrs. NOTE: The children listed may belong to someone else, (possibly his daughter) as they do not fit the ages of Daniel's known children. Also note, the known sons of Daniel who came to Canada (Seth, Lewis, John, and David Alston are listed separately by D. G. Bell in "Early Loyalists of Saint John".

Children of Daniel ⁵ and Catherine (Campbell) Dunham: born in Woodbridge NJ [Myers 566]. Note: Since these children were baptized in St. John Episcopal Church in Elizabethtown I believe that this family must have resided in that town.

All children except Campbell ⁶ were U. E. Loyalists and went to New Brunswick Canada

David Alston ⁶ Dunham (1762-1845)


David Alston ⁶ Dunham (Daniel ⁵, Daniel ⁴ David ³ Dunham, Jonathan ² Dunham/alias Singletary, Richard ¹ Singletary) born in Woodbridge, Middlesex County New Jersey or in Elizabeth, (now Union County) New Jersey say 1762, ^[1] died in St. John, New Brunswick, Canada 13 March 1845 ^[2]. He married in 1795 Mary Ann Cathline, ^[3] daughter of Philip Cathline. [Ref. 1-3, Myers p. 567] She was born say 1775 in Pennsylvania. She died 3 October 1851 in (Carleton) Saint John, New Brunswick Canada. (at the home of her son George C. Dunham. Info from the New Brunswick Courier issue 4 October 1851). Both are buried in the Church of England Cemetery. Philip Keithland/Cathline (c.1747-1820) arrived with the Loyalists at the mouth of the St. John River in 1783, (now Saint John, N.B.) along with his wife, son, daughter and 2 children under 10 years old.

Daniel ⁵ Dunham received a town lot, Parrtown #687, which is at the corner of Orange and Wentworth Streets in Saint John. He also received later land grants but was on the list of Freeman of the City in 1785 with occupation of joiner. After his death in 1821, the Parrtown lot # 687 was sold by his heirs as can be seen in the deed below.

He is buried in the Codys United Baptist Cemetery on Route 710 which is located between Thornetown and Codys, Queens County, New Brunswick. He married first on 6 November 1827 Mary Ann Briggs (1803-1870). They resided at Long Island, Queen's County in 1870 where she died. He married second on 24 October 1874 Rebecca G. Thorne. She is also buried in the Codys United Baptist Cemetery, Codys, Queens County, New Brunswick. She was the daughter of William Butler Thorne (1803-1883) and Catherine Worden (1801-1901).



David Elson ⁸ Dunham was a well-known architect in Saint John and designed many important buildings including office buildings, banks and church structures. A sample of his architectural drawings may be seen, together with other family information, in the Dunham and McDougall Family Collection, [MC167] located at the Provincial Archives of New Brunswick. The collection also includes Samuel Dunham's book of timber surveys from 1846-1849 which indicates that his occupation at that time was as a timber surveyor in Hampstead.

Several pages from this collection were sent to us by genealogist Daphne Wetmore, Fundy Coast Genealogy, Saint John, New Brunswick, Canada and they are reproduced below, courtesy of Daphne Wetmore and Deborah Dunham.

The death of David E. DUNHAM took place at his residence, Princess St., Saint John at an early hour this morn. He was an architect of no mean ability. The fire of 1877 swept away many of the fruits of his labors, but enough remain to bear testimony to his skill. Among the buildings we might mention Calvin Church, The Maritime Bank Building (destroyed 1877), Crawford's Block, King Square; Continiental Hotel, King Square; Wiggins Male Orphan Asylum (destroyed 1877); new wing of Alms House; Baptist Parsonage, Portland; Masonic Hall, Carleton; Catholic School, Carleton; St. Luke's Church, Portland; the old Exhibition building; and a large number of private dwellings in the City, Portland and throughout the Province. Mr. Dunham was a native of Hampstead (Queens Co.) and came to Saint John in 1863. He died at the age of 43.

After the untimely death of David Elson ⁸ Dunham his widow took all five boys and moved to Toronto.

Roy Wolsey ⁹ **Dunham** born 5 August 1882 in Saint John, New Brunswick, Canada; died 16 April 1951 in Detroit, Michigan. He married 7 November 1910 Georgina May Rice (1892-1921), daughter of Mr. and Mrs. George Ellis Rice of Toronto, Canada [Ref. The Toronto Star, Nov. 8, 1910, p. 10].

Roy Dunham appears on the 1911 census in Ontario Province, Toronto North, Dist. 126.

By the time of the 1920 US Federal census Roy W. and his wife May were living in Grand Rapids, Kent Co. Michigan where Roy was listed as a Traveling Salesman in the Confectionary Industry. He was listed as a naturalized citizen with year date of naturalization in 1916.

Roy Joseph ¹⁰ **Dunham** born 3 August 1911 in York, Ontario, Canada; died in August 1960 in Oakland County, Michigan. He married first 20 June 1936 Caroline J. Novak of Detroit, Michigan. He married second Carolyn Rose Mesker, 13 May 1943 in Detroit, Michigan. Roy Joseph Dunham (1911-1960)

In September of 2025 Deborah May Dunham, daughter of Roy Joseph Dunham, sent a collage of photos to be printed on the Facebook page of the Dunham Genealogy Research Association in commemoration of her father's mission on September 2, 1945. She has described that mission and I want to include her words (below).

"My father **Roy Joseph Dunham** (1911-1960) was born in Toronto (son of Roy Wolsey Dunham and grandson of David Elson Dunham architect of St. John New Brunswick). Due to a missed commissioning letter from the Royal Canadian Airforce, he ended up joining the US army in

which he served for three long hard years, flying dozens of missions from the island of Tinian in the Mariana Islands.

On September 2, 1945, as my father flew over Tokyo Bay in formation with 400 other B-29 bomber crews, Roy Joseph Dunham (whose squadron was based on the island of Tinian) had a bird's eye view of the historic signing of the surrender by Emperor Hirohito to General Douglas MacArthur. On the 80th anniversary of this momentous day, I wanted to commemorate my father's service to his adopted country by sharing excerpts from one of his letters to my mother describing his part on that day, and poignantly, what followed.

"As 'old dugout Doug' (MacArthur) was signing the long-awaited document, our ship came down out of formation and buzzed over the battleship Missouri at 300 feet. Boy what a view. All of the sailors in their white uniforms standing at attention at the rails and the Army officers in khaki standing in groups on the deck. The ship was in full regalia, all flags flying. Surrounding the big ship were scores of other battle wagons and hospital ships. We also had the actual broadcast from the battleship on our shortwave set What an occasion. . . The air was full of B-29's and Navy fighter planes roaring over in wave after wave. . .

"After the formalities were over, we flew around for several hours looking at the terrible damage inflicted upon the Japanese capitol. It was simply appalling to see such a great city levelled so completely. But this was nothing to what we were to see the next few days. That trip took only 16 hours, after refueling and sleeping about 4 hours, we took off with our bomb bays full of supplies for our stranded prisoners away up in Kyushu. The trip was a killer. We ran into a terrible electric storm which almost downed our ship. The storm lasted nearly four hours and every minute, we thought it would be our last . . .

"Finally, we located the prisoner of war camp and came down within several hundred feet and saw our boys standing in a large group waving their hands and going wild. We dropped the huge bundles of food and medical supplies by parachute, and they all gave us a real salute. Gosh it gave me goose pimples just to think of how miserable they must have been...

After another storm caused damage to the aircraft requiring a repair stop at Iwo Jima, and another 31-hour long trip for more POW supply drops, he writes "Hold your breath! We then went up to China then over to Okinawa landing for a few hours and then over to Manilla... Total time elapsed, three days. I feel like I have been whipped with a rubber hose for hours..."

And all this was AFTER victory was declared. While sadly my father died in 1960, before I was old enough to know him, I am grateful for over 200 letters he wrote (and sketched) of his harrowing wartime experiences between 1942-1946. Thank you, dad! Now we know what all those medals were for."
