Salute to Paul C. Dunham

One of the guiding lights in the formation and operation of Dunham-Singletary Family Connections is Paul Clinton Dunham. Paul has been instrumental in getting the Articles of Incorporation written, adopted and filed under the Montana State code for organizations. Paul has also been the Treasurer of DSFC since its inception.

Paul has done other duties for DSFC as well, including maintaining a web site where DSFC membership information, a copy of the by-laws, past newsletters and photos may be seen. Paul has done the work of Group Administrator/Coordinator of the very important Dunham DNA project. Paul also maintains the second DSFC web site where the genealogical information is found at *Dunham Families in America*.

DNA MATCHES for the DUNHAM-SINGLETERY GROUP

In the last issue of the *Dunham-Singleton Family Connections* newsletter I compiled an article showing the results of the DNA-Y chromosome testing for those men belonging to the Deacon John Dunham line. In this issue I show the results of the DNA-Y chromosome testing for those men belonging to line which stems from Jonathan² Dunham alias Singleton. Jonathan² was the son of Richard Singleton, thus his descendants (even though they have the Dunham surname) will match the descendants of Richard Singleton. During the testing process we invited known descendants of Richard Singleton (who descended from Jonathan² Dunham alias Singleton's brothers and retained the Singleton surname) to participate in the DNA testing process.

To date 22 men have participated in this DNA-Y chromosome group. All are haplogroup I. The control is David Lee Dunham who was the first participant of this group and whose genealogical research proves that he is a descendant of Jonathan² Dunham. Note that some of these men use the surname spelling of DONHAM, or DUNNAM. Results are given for the DYS allele (or marker) levels of 12 and 25. There have not been enough men tested at the 37 marker level to show meaningful results.

Following each category you will see the explanation given by Family Tree DNA of the probability of a match. Family Tree DNA has also given the markers which tend to move (or mutate) most rapidly. The markers which are mismatched in all of the men tested at the 24/25 or the 23/25 level fall into the category of markers which move most rapidly.

While evaluating the above DNA-Y chromosome results it is apparent that the DYS mutations which occur at DYS389-2; DYS449; and DYS 464b,c,&d occur in the descendants of Jonathan ² Dunham who went south to South Carolina and those of that branch who migrated to Georgia. The Reverend James T. Dunnam did extensive research on these Dunhams/Dunnams and that research is posted on the web site www.freepages.genealogy.rootsweb.ancestry.com/~pastor/ Rev. James T. Dunnam is now deceased. It is also interesting to note that the mutation at DYS449 is shared by all three Singletary men as well as Sam E. Dunnam and James T. Dunnam.

Peleg K. Dunham And the Battle of Lake Erie

On September 10, 1813 Oliver Hazard Perry lead American forces in a decisive naval victory at the Battle of Lake Erie. Perry's flag ship, the **USS Lawrence** was severely disabled in the encounter and Perry had to transfer his command to the **USS Niagara**. With his crew the **USS Niagara** pounded the Royal Navy ships until they surrendered. Perry's battle report to General William Henry Harrison was the famous line: "We have met the enemy and they are ours. . ."

Oliver Hazard Perry, United States Navy Commodore, was born in South Kingstown, Rhode Island 23 August 1785. As a boy Perry lived in Newport. It is possible that he knew, or knew of, Peleg K. Dunham, also residing in Newport. Peleg's father was a sail maker with his Sail Loft located on the wharf in Newport. Oliver's father was a U. S. Navy Captain of a sailing ship. At the age of 13 Perry was appointed a midshipman in the U. S. Navy. Perry had the command of several ships prior to the War of 1812. His leadership in that war aided the successful outcomes of all of the Lake Erie military campaign victories. Oliver Hazard Perry died of yellow fever in Port of Spain, but his remains were returned to Rhode Island and he is buried in Newport's Island Cemetery.

Peleg K. Dunham

Peleg K. Dunham was born in Newport 17 August, 1794, the son of Charles C. and Hannah (Kaighn) Dunham. The Dunham line back from Peleg K. ⁷ Dunham is (Charles C. ⁶, Robert ⁵, Daniel ^{4,3} Joseph ² John ¹ Dunham.) Peleg K. Dunham entered military service in the navy in 1812. He was on the flagship under Oliver Hazard Perry during the Battle of Lake Erie. From the issue of the newspaper *Rhode Island Republican*, Vol. 14, Issue 21, p. 3: "Died in this town on Friday evening last, of consumption, Peleg K. Dunham of the U. S. Navy, aged 25. He entered service in 1812. He served on the flagship under Perry in the Battle of Lake Erie on September 10th, 1813 where he behaved courageously and was afterward promoted to Lieut."

Tall Ships - Parade of Sail Newport, Rhode Island

I spend the month of July visiting my daughter who lives in Newport, Rhode Island. On 9 July, 2012 the Parade of Sail of fourteen "Tall Ships" presented an opportunity for me to view these majestic sailing ships of a bygone era. One of the ships taking part in the Parade of Sail was the **Pride of Baltimore II** an historic replica of a ship from the War of 1812 period. While a smaller ship than the flagship **USS Lawrence** would have been, schooners were among the fleets of both the Royal Navy and the U. S. Navy. (see photo on next page)

Dunhams in the War of 1812

On June 1, 1812, President James Madison sent a message to the Congress recounting American grievances against Great Britain. These grievances included trade restrictions brought about by Britain's ongoing war with France, the impressments of American merchant sailors into the Royal Navy, and British use of American Indian tribes against American expansion. After deliberations in the House of Representatives and the Senate, both bodies voted in favor of calling for a Declaration of War. The conflict began formally on June 18, 1812, when Madison signed the measure into law.

The war was fought in three theatres: at sea; on the frontier (which at that time was the Great Lakes and the St. Lawrence River); and in the south. At sea, warships and privateers of both sides attacked each other's merchant ships. The British blockaded the Atlantic coast of the U.S. and mounted large-scale raids.

The U.S. started a rapidly-expanded program of building warships at Sackets Harbor on Lake Ontario, where 3,000 men were recruited, many from New York City, to build 11 warships early in the war. In 1813, the Americans won control of Lake Erie in the Battle of Lake Erie and cut off British and Native American forces in the west from their supply base. In October 1813 Tecumseh, the leader of the tribal confederation, was killed and his Indian coalition disintegrated.

After Napoleon abdicated on April 6, 1814, the British could send veteran armies to the United States, but by then the Americans had learned how to mobilize and fight. The British launched a major invasion of New York State with these veteran soldiers. On September 11, 1814 the American fleet gained control of Lake Champlain at the Battle of Plattsburgh, and this ended the British invasion of the northern states.

The South and the Gulf Coast saw major battles. A British invasion of Louisiana (unknowingly launched after the Treaty of Ghent was negotiated to end the war) was defeated, with very heavy British losses, by General Andrew Jackson at the Battle of New Orleans in January 1815.

Once Britain had defeated Napoleon in 1814, France and Britain became allies. Britain ended the trade restrictions and the impressments of American sailors, thus removing two causes of the war. After two years of warfare, the major causes of the war had disappeared. Neither side had a reason to continue or a chance of gaining a decisive success that would compel their opponents to cede territory or create advantageous peace terms. As a result, the two countries signed the Treaty of Ghent on December 24, 1814. News of the peace treaty took two months to reach the U.S., during which fighting continued. The official end of hostilities came on February 18, 1815.

Identification of some of the Dunhams who served during the War of 1812 follows. This group of Dunhams are only those found with pension files. There were many others who will be listed in the future. Note that I have not identified all these lines as yet, and any help in identifying them would be appreciated.

It is planned to place a spread sheet identifying all the Dunhams who saw service in the War of 1812 on the *Dunham Families in America* web site. That project is still on-going.
